


Front Brush Guard: for Polaris RZR® XP 1000


Do not tighten hardware completely unless noted. Keep all components removed from machine.


- 1. Remove stock Brush Guard if applicable and loosen Winch Cover screws. See Figs. 1 1b.
- 2. Install Front Brush Guard to machine:
- Secure lower section to Frame with M8-1.25 x 25mm Lg. FHCS and M8-1.25 Nylock Nuts.
 See Figs. 2 2a.
- Secure upper section to Frame with M12-1.75 x 30mm Lg. FHCS and M12 Lock Washers. See Figs. 2- 2a.
- 3. Align to machine and tighten all hardware.
- 4. Install optional LED Light Bar Mounting Brackets. See last pages of installation instructions. (illustrations on following pages)

















12" LED Light Bar SuperATV p/n LB3-12









